IN 2021, PARKS CONTINUED TO BE A RELIABLE AND SAFE OUTLET FOR GATHERING AND COMMUNITY. OUR VOLUNTEER PROGRAM SAW INDIVIDUAL VOLUNTEER NUMBERS CONTINUE TO GROW, AND CORPORATE VOLUNTEERS RETURNED TO PRE-PANDEMIC LEVELS. MANY OF THE CORPORATE PROJECTS WERE A PLACE FOR CO-WORKERS TO REUNITEOR IN SOME CASES MEET FOR THE FIRST TIME! BY THE END OF 2021, 5,084 VOLUNTEERS HAD CONTRIBUTED AN INCREDIBLE 14,034 HOURS OF SERVICE TO OUR PARKS.
